## Can you confirm if F-gases will be discussed from October? Our last information was that the Committees probably won't get to it even in the December meeting.

The PFAS restriction proposal, which includes certain F-gases, is moving through the evaluation stages with ECHA. During our presentation, it was mentioned that F-gases would be looked at from October onwards. As of now, no official update suggests that the review of F-gases will be completed during the December 2024 meeting of the relevant committees.

However, considering the complexity of the analysis, decisions may extend into 2025. ECHA regularly posts about these developments, so we recommend keeping an eye on their official releases and on updates from our team at Chemical Watch News & Insight.

### Which revision of GHS will be implemented in Ukraine for hazard classification and labeling?

## Are there any labs that can certify batteries so that we could add a CE mark directly to the battery?

Yes, there are several laboratories and certification bodies that can certify batteries in Europe. Some of the most prominent labs offering testing and certification services are <u>TÜV SÜD</u>, <u>SGS</u> and <u>Intertek</u>.





#### Do you know when ATP 22 will be published in the EU?

The notification had proposed an adoption date in the second quarter of 2024, but that deadline has already passed with no adoption yet. While there's still a chance it could be published in the *Official Journal* later this year, it's more likely to occur in early 2025.



A general question about scope. Are motorcycle helmets and snowmobile helmets and goggles considered apparel under PFAS regulations in US states? I don't see regulations for PPE outside of firefighting equipment.

Motorycle helmets, snowmobile helmets and goggles are not usually considered apparel. Helmets are likely to fall under personal protective equipment (PPE), and goggles may be considered a medical device as they are eyewear.

US regulations were not covered in this webinar.
